IOC, the nation's biggest oil firm controlling roughly half of the retail fuel market, will source the BS-VI fuel to meet Delhi's requirement from its Mathura and Panipat refineries, while Hindustan Petroleum (HPCL) will do so from its joint venture refinery at Bathinda. Bharat Petroleum (BPCL) will supply the fuel from its Bina refinery.

As per IOC, for petrol engines, one of the most critical specifications is Research Octane Number (RON), which has improved from 88 in BS-II to 91. It is on par with regular 91 octane gasoline (petrol) required for Euro VI emission norms. Sulphur specification for petrol and diesel will be reduced 50 times from a level of 500 ppm for BS-II fuel to 10 ppm in BS-VI. Previously, the fuels meeting Euro-IV or Bharat Stage (BS)-IV specifications were to be supplied throughout the country by

to all companies their own retail dealers' margins. DAP, MoP and fertilisers are declining.
