26.5 लाख की लूट, पुलिसकर्मी समेत दो गिरफ्तार

बंगलुरु, 25 अगस्त (भाषा)।

कर्नाटक में एक व्यक्ति से 26.5 लाख रुपये की लूट के आरोप में एक पुलिस उप निरीक्षक को तथा पत्रकार होने का दावा करने वाले एक अन्य व्यक्ति को गिरफ्तार किया गया है।

पुलिस ने सोमवार को बताया कि 31 वर्षीय पुलिस उप निरीक्षक जीवन कुमार थॉमस और एक कन्नड़ समाचारपत्र में संवाददाता होने का दावा करनेवाले 44 वर्षीय ज्ञानप्रकाश अंथोनाप्पा ने शिव कुमारस्वामी नाम के व्यक्ति को कथित तौर पर लूटने के लिए 19 अगुस्त की एक गिरोह की मदद ली। उन्होंने बताया कि यह घटना कुमारस्वामी के चिक्कापेट मेट्रो स्टेशन के निकट सुबह पहुंचने पर हुई। उन्होंने बताया कि तीन लोगों ने कुमारस्वामी को रोका, उसका अपहरण करके उसे एक कार में बिठा लिया और उससे मोबाइल फोन छीनकर बंद कर दिया।

आरोपी कुमारस्वामी को यूनिटी बिल्डिंग में ले गए और उससे रुपए छीन लिए। इसके बाद इन अपराधियों ने उसे लालबाग के निकट एक होटल पर उतार दिया और उसे धमका कर कहा कि वह चुपचाप यहां से चला जाए। शिकायत के आधार पर आरोपियों के खिलाफ अपहरण, अवैध तरीके से कब्जे में रखने, धमकी, लूट और साजिश का मामला दर्ज कर लिया गया है।
