## तृणमूल ने राज्यसभा उपचुनाव के लिए जवाहर सरकार को नामित किया

कोलकाता, २४ जुलाई (भाषा)।

वृणमूल कांग्रेस (टीएमसी) ने राज्य में आगामी राज्य सभा उपचुनाव के लिए अपने प्रत्याशी के तौर पर पूर्व नौकरशाह जवाहर सरकार को शनिवार को नामित किया।

निर्वाचन आयोग ने 16 जुलाई को कहा था कि इस साल की शुरुआत में दिनेश त्रिवेदी के इस्तीफे से खाली पश्चिम बंगाल की राज्य सभा सीट के लिए उपचुनाव नौ अगस्त को होगा। पार्टी ने एक बयान में कहा कि हम संसद के ऊपरी सदन में जवाहर सरकार को नामित कर प्रसन्न हैं। राज्य में सत्तारूढ़ पार्टी ने कहा कि सरकार ने लोकसेवा में करीब 42 वर्ष दिए हैं और वह प्रसार भारती के पूर्व सीईओ भी रहे हैं।

# चिदंबरम की याचिका पर जांच एजंसी से मांगा जवाब

जनसत्ता संवाददाता नई दिल्ली, 24 जुलाई।

दिल्ली की एक अदालत ने आइएनएक्स मीडिया धनशोधन मामले से संबंधित विभिन्न दस्तावेज मांगने की पूर्व केंद्रीय मंत्री पी चिदंबरम की याचिका पर शनिवार को प्रवर्तन निदेशालय (ईडी) से जवाब मांगा।

विशेष न्यायाधीश एमके नागपाल ने ईडी को नोटिस जारी किया और नौ अगस्त तक जवाब देने का निर्देश दिया है। अदालत चिंदबरम की ओर से वकील अर्शदीप सिंह खुराना की ओर से दायर याचिका पर सुनवाई कर रही थी जिसमें उन्होंने ईडी को मामले से जुड़े विभिन्न दस्तावेजों के साथ ही दाखिल किया गया आरोप-पत्र मुहैया कराने का निर्देश देने का अनुरोध किया। इसमें ईडी से रिकार्ड की पृष्ठ संख्या में गलतियों को सुधारने तथा गायब दस्तावेजों को भी उपलब्ध कराने का निर्देश देने की अपील की गई है। केंद्रीय जांच ब्यूरो (सीबीआइ) ने आइएनक्स मीडिया भ्रष्टाचार मामले में चिदंबरम को 21 अगस्त, 2019 को गिरफ्तार किया था। उसी साल, 16 अक्तूबर को ईडी ने उन्हें धनशोधन से संबंधित मामले में गिरफ्तार किया।
