गाब्रिएला डेमाट्रैड्स दूसर दिन भी एनसीबी के समक्ष पेश हुई

मुंबई, 12 नवंबर (भाषा)।

अभिनेता अर्जुन रामपाल की पार्टनर गैब्रिएला डेमाट्रैड्स बॉलीवुड में कथित नशीली दवाओं के उपयोग संबंधी मामले की जांच के सिलसिले में गुरुवार को दूसरे दिन भी यहां स्वापक नियंत्रण ब्यूरो (एनसीबी) के समक्ष पेश हुई। एक अधिकारी ने यह जानकारी दी। एनसीबी अधिकारियों ने बुधवार को डेमाट्रैड्स से लगभग छह घंटे तक पूछताछ की थी। अधिकारी ने बताया कि उन्हें पूछताछ के लिए फिर से बुलाया गया था, जिसके बाद वे गुरुवार को दक्षिण मुंबई के बलार्ड एस्टेट में स्थित एनसीबी के अंचल कार्यालय में पहुंची। एनसीबी ने इससे पहले सोमवार को अभिनेता के आवास पर छापेमारी के बाद रामपाल और डेमाट्रैड्स को बुलाया था। जांच एजेंसी ने छापेमारी के दौरान लैपटॉप, मोबाइल फोन और टैबलेट जैसे इलेक्ट्रॉनिक गैजेट को जब्त किया था और अभिनेता के चालक से भी पूछताछ की थी।

अर्नब ने सत्र अदालत से जमानत याचिका वापस ली

मुंबई, 12 नवंबर (भाषा)।

रिपब्लिक के प्रधान संपादक अर्नब गोस्वामी ने सुप्रीम कोर्ट से राहत मिलने के बाद आत्महत्या के लिए कथित तौर पर उकसाने के मामले में रायगढ़ जिले में अलीबाग की सत्र अदालत से अपनी जमानत याचिका गुरुवार को वापस ले ली। सुप्रीम कोर्ट द्वारा बुधवार को अंतरिम जमानत दिए जाने के बाद उन्हें तलोजा जेल से रिहा कर दिया गया। अर्नब को न्यायिक हिरासत में जेल भेजा गया था। न्यायालय ने मामले में दो अन्य आरोपियों को भी अंतरिम जमानत दे दी थी। गोस्वामी ने अलीबाग में सत्र अदालत के समक्ष सोमवार को नियमित जमानत याचिका दायर की थी। आत्महत्या के लिए कथित तौर पर उकसाने का मामला अलीबाग में ही दर्ज है।

- The Company's operations and financial results for the six months ended 30th September, 2020 have been adversely impacted by the outbreak of COVID-19 pandemic and the consequent lockdown announced by the Government of India due to which the operations were suspended for part of the first quarter and gradually resumed with requisite precautions. The Company will continue to closely monitor any material changes to future economic conditions.
- Given the nature of business of the company and product mix in the respective quarter the result of any quarter may not be a true and/or proportionate reflection of the annual performance of the company. Further quarter to quarter results are also affected by the type of the products manufactured/sold during that quarter.
- The above financial results have been approved by the Audit Committee & Board of Directors at their meeting held on 12th Nov., 2020. The statutory auditors have carried out a limited review of the results quarter ended 30th Sept., 2020 and have issue an unmodified report on these results.
